The purpose of this letter is to certify certain state tax revenue for Fiscal Year 2025. Attachment A presents the revenue by tax category as it appears on the books of the Commonwealth. Kindly use this information as you submit subsequent reports to the Office of the State Auditor pursuant to M.G.L. c. 62F, § 5.

At a later date, you may notice a variance in the amount reported for deeds tax revenue in the Commonwealth's Statutory Basis Financial Report (SBFR). This is the result of the use of accrual-based accounting in those reports. The figures in this certification do not include accruals.

In closing, the cooperative efforts of staff from the Office of the State Auditor, the Department of Revenue, the Office of the Treasurer and Receiver General, and the Office of the Comptroller have yielded excellent results. Strict observation of the Comptroller's year end closing instructions allowed for the accurate and timely certification of the Fiscal Year 2025 tax revenues.
