RE: March 2024 Certification of MBTA Base Sales Tax Revenues for Fiscal Year 2025

Dear Secretary Gorzkowicz and Secretary Tibbits-Nutt:

Pursuant to M.G.L. c. 10, § 35T, this letter certifies for Fiscal Year 2025 the MBTA Base Sales Tax Revenue. This certification was done in consultation with the Department of Revenue. The details of the calculations are shown in the table below.

Base Sales Tax Revenue: The base revenue amount for Fiscal Year 2025 is calculated by multiplying the base revenue amount for the prior fiscal year by the change in the calendar year 2023 consumer price index for all urban consumers for the Boston metropolitan area as determined by the Bureau of Labor Statistics of the United States Department of Labor. This figure is then compared to the percent increase in gross sales tax revenues received pursuant to M.G.L. c. 64H and M.G.L. c. 64I for the same period. The calendar year 2023 "gross sales tax revenues" is defined as sales tax receipts by taxpayers from nonexempt sales, less amounts abated, refunded, or reimbursed.

Pursuant to Section 35T, if the calendar year 2023 inflation rate is greater than 3.000%, the Fiscal Year 2023 base revenue will be 3.000%, regardless of the increase in calendar year 2023 gross sales tax revenue. The calendar year 2023 inflation rate was 3.709%; therefore, the base sales tax revenue growth rate for Fiscal Year 2025 is 3.000%. The table on the next page presents the calculation of the base revenue amount.

I certify to you that the base sales tax revenue amount for Fiscal Year 2025 increased by an amount of \$34,869,903, or 3.000% compared to the Fiscal Year 2024 figure of \$1,162,330,114. The base revenue amount for Fiscal Year 2025 is \$1,197,200,017.
