As required by Section 2 Chapter 133 of the Acts of 2016 and Chapter 47 of the Acts of 2017, the Office of the Comptroller is submitting these accounts payable BFY2017 and first quarter BFY2018, as of September 30, 2017, reports on "Settlements and Judgments" to the House and Senate Committees on Ways and Means.

The attached reports contain information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384.

The total spent during the accounts payable period of BFY2017, from 1599-3384, was \$1,799,938 and the total spent during the first quarter of BFY2018 was \$1,454,596.
