Dear Senator Spilka and Representative Dempsey:

As required by Section 2 Chapter 133 of the Acts of 2016, the Office of the Comptroller is submitting the third quarter BFY2017, as of March 31, 2017, report on "Settlements and Judgments" to the House and Senate Committees on Ways and Means.

The attached report contains information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384.

In BFY2017, \$2,000,000 was appropriated to the settlement and judgment account (1599-3384). Supplemental budget c5 s2 was enacted on 3/28/17 for an additional \$6,000,000. A total of \$1,009,513 was spent during the third quarter. In summary:
