Dear Senator Spilka and Representative Sánchez:

As required by Section 2 Chapter 133 of the Acts of 2016, the Office of the Comptroller is submitting the fourth quarter BFY2017, as of June 30, 2017, report on "Settlements and Judgments" to the House and Senate Committees on Ways and Means.

The attached report contains information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384.

In BFY2017, \$2,000,000 was appropriated to the settlement and judgment account (1599-3384). Supplemental budgets c5 s2 (\$6,000,000) and c20 s2 (\$2,000,000) were enacted for an additional \$8,000,000. A total of \$5,252,755 was spent during the fourth quarter. In summary:
