Dear Vice Chair Lovely and Chairman Sánchez:

As required by Section 2 Chapter 47 of the Acts of 2017 and Chapter 154 of the Acts of 2018, the Office of the Comptroller is submitting these accounts payable BFY2018 and first quarter BFY2019, as of September 30, 2018, reports on "Settlements and Judgments" to the House and Senate Committees on Ways and Means.

The attached report contains information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384. This information, including payee names, is now posted quarterly on the comptroller's transparency website, CTHRU for yours and your constituents' review.

The total spent during the accounts payable period of BFY2018, from 1599-3384, was \$1,111,942 and the total spent during the first quarter of BFY2019 was \$56,401.

#### In summary:

In BFY2018, \$1,000,000 was appropriated to the settlement and judgment account (1599-3384). Supplemental budget c 90 s 2 was enacted for an additional \$12,000,000. A total of \$10,488,376 was spent through the accounts payable period of BFY2018.
