As required by Section 2 Chapter 47 of the Acts of 2017, the Office of the Comptroller is submitting the second and third quarter BFY2018 reports on "Settlements and Judgments" to the House and Senate Committees on Ways and Means.

The attached reports contain information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384. This information, including payee names, is now posted quarterly on the comptroller's transparency website, CTHRU for yours and your constituents' review.

The total spent during the second quarter of BFY2018, from 1599-3384, was \$1,765,340 and spent during the third quarter \$1,098,983.

In summary:

In BFY2018, \$1,000,000 was appropriated to the settlement and judgment account (1599-3384). A total of \$4,318,919 was spent through the third quarter.
