Dear Chairman Rodrigues and Chairman Michlewitz:

Pursuant to Section 2 of Chapter 154 of the Acts of 2018 and Section 2 of Chapter 41 of the Acts of 2019, the Office of the Comptroller hereby submits to the House and Senate Committees on Ways and Means a report on payments made from the settlements and judgments account (1599-3384) in FY2019 and during the first quarter FY2020, as of September 30, 2019.

The attached report contains information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384. This information, including payee names, is now posted quarterly on the Comptroller’s transparency website, [CTHRU](#) for your and your constituents’ review.

### **FY2019**

The total spent from 1599-3384 in FY2019 was \$16,043,294, of which \$5,191,302 was spent in the Accounts Payable Period (7/1/19-8/31/19; for expenses of the fiscal year ending 6/30/19).

In summary:

In FY2019, \$1,000,000 was appropriated to the settlement and judgment account (1599-3384). In addition, \$1,911,624 was carried forward from FY2018. A total of \$16,043,294 was spent through the accounts payable period of FY2019.

**FY2020**

In FY2020, \$1,000,000 was appropriated to the settlement and judgment account (1599-3384). In addition, \$1,068,329 was carried forward from FY2019. Additionally, pursuant to legislation, a formula is used by which the Secretary of Administration and Finance establishes a spend in anticipation ceiling amount, to which the Comptroller's Office may spend without further authorization. For FY2020, the ceiling has been set at \$12,084,884.

A total of \$1,125,126 was spent during the first quarter of FY2020.
