RE: Settlements and Judgments Report-FY20 Quarter 3

Dear Chair Rodrigues and Chair Michlewitz:

Pursuant to Section 2 of Chapter 41 of the Acts of 2019, the Office of the Comptroller ("CTR") hereby submits to the House and Senate Committees on Ways and Means a report on payments made from the settlements and judgments account (1599-3384) during the third quarter of FY2020, as of March 31, 2020.

The attached report contains information regarding payments, by department, of settlements and judgments from appropriation account 1599-3384. This information, including payee names, is now posted quarterly on CTR's transparency website, <u>CTHRU</u> for your and your constituents' review.

In FY2020, \$1,000,000 was appropriated to the settlements and judgments account (1599-3384). In addition, \$1,068,329 was carried forward from FY2019. Additionally, pursuant to legislation, a formula is used by which the Secretary for Administration and Finance establishes a spend in anticipation ceiling amount, to which CTR may spend without further authorization. For FY2020, the ceiling was set at \$12,084,884.

A total of \$1,480,243 was spent during the third quarter of FY2020.

As such, as of the March 31, 2020 spending, the 1599-3384 account requires at least \$1,744,654 to support funds beyond the available appropriated funds while also having \$8,271,801 available in spending, though not yet appropriated.
