^{**} Approximately \$6M in Fiscal Year 2022 claims were paid in Fiscal Year 2023 The majority of the first quarter expenditures were related to claims that were submitted for payment during the preceding fiscal year but had not been paid as of the date of the Fiscal Year 2023 General Appropriation Act because there were no funds remaining in the Settlements and Judgments reserve. The closeout supplemental budget for Fiscal Year 2022 appropriated an additional \$10 million to the reserve, replenishing the amount available for FY2023 Settlements and Judgments. In addition, \$8,286,615 was appropriated in the supplemental budget, bringing the total available funding to \$28,286,615.00 for Fiscal Year 2023.
