Dear Chair Rodrigues and Chair Michlewitz:
Pursuant to Section 2 of Chapter 126 of the Acts of 2022, the Office of the Comptroller hereby submits to the House and Senate Committees on Ways and Means a report on payments made from the Settlements and Judgments reserve (1599-3384) for the fourth quarter of Fiscal Year 2023.

The attached report provides information on payees, amounts, and the associated department or agency for settlements and judgments paid from appropriation account 1599-3384. This information is also posted quarterly on the Comptroller's transparency website, CTHRU, which may be accessed via this portal link, https://www.macomptroller.org/cthru.

Spending in the fourth quarter of Fiscal Year 2023 (April 1, 2023 - June 30, 2023)
A total of $\$ 7,801,205$ was paid from the Settlements \& Judgements account during the fourth quarter (Q4) of Fiscal Year 2023.

Recap for the full Fiscal Year 2023 period (July 1, 2023 - June 30, 2023)
The table on the following page provides a recap of both funding and expenditure on Settlements \& Judgements for the period. Notably, during Fiscal Year 2022, the available funds and the spend-in-anticipation allowance had been depleted by the end of April 2022. In the absence of interim supplementary funding, items awaiting payment continued to build through the end of the Fiscal Year on June 30, 2022, by which point they totaled roughly $\$ 6,000,0000$.

Settlements and Judgements Report - Fiscal Year 2023 Quarter 4
August 31, 2023
As is normally the case, the General Appropriations Act for the new fiscal year (Fiscal Year 2023 in this case) was passed before the final supplementary budget for Fiscal Year 2022. The available funds were applied first to the oldest payable items. In effect, when the final supplementary budget for Fiscal Year 2022 later passed, it then replenished the amount available for payables arriving after July 1, 2022.

Because the total amount of payable items during Fiscal Year 2023 was large, supplementary funding was provided in March 2023 in Chapter 2 of the Acts of 2023. I am thankful to the Legislature and the Administration for this additional funding; it allowed the Settlements \& Judgements account to end Fiscal Year 2023 with a small positive balance and no unpaid items, which I believe all would agree is a positive outcome.
