RE: Settlements and Judgments Report —Fiscal Year 2024 Quarter 4

Dear Chair Rodrigues and Chair Michlewitz:

Pursuant to Section 2 of Chapter 28 of the Acts of 2023, the Office of the Comptroller hereby submits to the House and Senate Committees on Ways and Means a report on payments from the Settlements and Judgments reserve (1599-3384) for the fourth quarter of Fiscal Year 2024.

The Settlements and Judgements reserve entered Fiscal Year 2024 in a strong position because of the substantial \$15 million appropriation included by the Legislature in the General Appropriation Act. Nevertheless, the fund was depleted by Quarter 2. Supplemental funding was appropriated in Quarter 4, allowing for payment of \$14,095,775 in approved claims. This leaves \$184,131 in the reserve to process claims during the Accounts Payable Period (July 1 – August 31).
