RE: Settlements and Judgments Report —Fiscal Year 2025 Quarter 3

Dear Chair Rodrigues and Chair Michlewitz:

Pursuant to Section 2 of Chapter 140 of the Acts of 2024, the Office of the Comptroller hereby submits to the House and Senate Committees on Ways and Means a report on payments from the Settlements and Judgments reserve (1599-3384) for the third quarter of Fiscal Year 2025.

The Settlements and Judgements reserve entered Fiscal Year 2025 with a \$1 million appropriation included by the Legislature in the General Appropriation Act. In August 2024, the spend in anticipation ceiling was increased by the five-year historical expenditure average and balances were forwarded from Fiscal Year 2024, allowing for an additional \$18,614,487 in spending. The chart below shows the funding and spending for the third quarter of Fiscal Year 2025

* The “spend in anticipation” mechanism provided in the FY25 GAA allows payments to be made beyond the appropriated fund availability up to a defined ceiling, determined by the average of five years of payment history.
