RE: Settlements and Judgments Report —Fiscal Year 2025 Quarter 4

Dear Chair Rodrigues and Chair Michlewitz:

Pursuant to Section 2 of Chapter 140 of the Acts of 2024, the Office of the Comptroller hereby submits to the House and Senate Committees on Ways and Means a report on payments from the Settlements and Judgments reserve (1599-3384) for the fourth quarter of Fiscal Year 2025.

The Settlements and Judgments reserve entered Fiscal Year 2025 with a \$1 million appropriation, which was included by the Legislature in the General Appropriation Act. In August 2024, the “spend in anticipation” ceiling for the Reserve was increased by the amount of the five-year historical expenditure average, and the remaining balance in the fund at the end of Fiscal Year 2024 was carried forward to Fiscal Year 2025, allowing for an additional \$18,614,487 in spending from the Reserve. The chart below shows the funding and spending for the fourth quarter of Fiscal Year 2025. As you can see, at the conclusion of Quarter 4 there was \$8,030 remaining in the reserve to process claims during the Accounts Payable Period (July 1 – August 31).
