Pursuant to Section 2E of the Fiscal Year 2022 General Appropriations Act, Chapter 24 of the Acts of 2021, I hereby submit an updated Fiscal Year 2022 transfer schedule to reflect the supplemental increases authorized in Section 2 of Chapter 29 of the Acts of 2021 and Section 43 of Chapter 42 of the Acts of 2022.

• 1595-1068 -- Medical Assistance Trust Fund, where the transfer provides an operating subsidy from the General Fund to the Medical Assistance Trust Fund for the MassHealth provider payment account for services provided; for public hospital transformation and incentive initiative payments; or, for Medicaid care organization payments under 42 CFR 438.6(c).

Total Amount: \$751,458,406. Monthly transfer amounts are shown in the attachment.
