Pursuant to Section 2E of the Fiscal Year 2023 General Appropriations Act, Chapter 126 of the Acts of 2022, I hereby submit a Fiscal Year 2023 transfer schedule for the following account:

- **1595-7066** (formerly 7066-0035) Massachusetts Science, Technology, Engineering, and Mathematics Grant (Pipeline) Fund, where the transfer provides an operating subsidy from the General Fund to the Pipeline Fund to increase the number of students who participate in programs that support careers in fields related to science, technology, engineering, and mathematics.
