Pursuant to Section 2E of the Fiscal Year 2023 General Appropriations Act, Chapter 126 of the Acts of 2022, I am submitting a Fiscal Year 2023 transfer schedule for the following account:

- 1595-1075 -- Workforce Competitiveness Trust Fund, where the transfer provides an operating subsidy from the Gaming Economic Development Fund to the Workforce Competitiveness Trust Fund for the development and implementation of employer and worker responsive programs to enhance worker skills, incomes, productivity, and retention, and to increase the quality and competitiveness of Massachusetts firms.
