
Pursuant to Section 2E of the Fiscal Year 2024 General Appropriations Act, Chapter 28 of the Acts of 2023, I am submitting a Fiscal Year 2024 transfer schedule for the following account:

- 1595-4506 -- Childhood Lead Poisoning Prevention Trust Fund, where the transfer provides an operating subsidy from the General Fund to the Childhood Lead Poisoning Prevention Trust Fund for the operation of the childhood lead poisoning prevention program, including the production and dissemination of educational and other materials pertaining to lead paint poisoning prevention and treatment; training of lead paint inspectors, and training of homeowners in those aspects of lead paint abatement or containment.
