Dear Committees on Ways and Means:

In accordance with Section 2E of Chapter 140 of the Acts of 2024, and Section 128 of Chapter 248 of the Acts of 2024 I am submitting a revised Fiscal Year 2025 transfer schedule for the Medical Assistance Trust Fund. The revised schedule reflects a reduction in the transfer amount. Delayed approval by the Centers for Medicare and Medicaid Services of a State Plan Amendment resulted in MassHealth expending less than appropriated in Fiscal Year 2025.

• 1595-1068-- Medical Assistance Trust Fund, where the transfer provides an operating subsidy from the General Fund to the Medical Assistance Trust Fund for the MassHealth provider payment account for services provided; for public hospital transformation and incentive initiative payments; or, for Medicaid care organization payments under 42 CFR 438.6(c).

Monthly transfer amounts are shown in the attachment.
